- c) Approved the proposal to apply for the Extension of Autonomous Status to the College by September 2022.
- d) Approved the proposal to prepare the documents and submit SSR to NAAC by December 2023.
- e) The Annual e-Governance Report was presented by Dr. Sr. Shiny K.P and it was approved by the Governing Board.

The Principal informed the members that offline classes have started regularly and VI Semester End Examinations also conducted on physical mode and over all pass percentage of the outgoing batch was 90%. She also informed that Community Projects and Internship was introduced to the students from the academic year 2021-22.

- c) Approved the proposal to start three New Degree courses namely B.Sc. Agriculture and Rural Development BBA Logistics Management and B.Sc. Clinical Nutrition Dietetics & Food Sciences in this academic year 2021-22.
- d) Approved to close 12 UG Unaided programmes due to lack of admission and also because of converting all Telugu Medium Courses into English medium by the Government of AP.
- e) Approved the proposal to apply for the extension of Autonomous Status to the College.
- f) The members approved the proposal to launch Virtual English Language Fellow programme in Collaboration with U.S. Consulate General, Hyderabad for Students intending to enhance Placements.

Sr. Shanta appreciated the functioning of the College and for conducting Various activities and wished the best to continue to enhance the quality of teaching and learning with innovative activities.

Prof. Janak Ahi, the UGC Nominee appreciated the Management for conducting many activities celebrating some of the important personalities Birthdays during pandemic period for all round development of the students She also asked the reasons for closing the Un-Aided UG courses. The principal explained there were Five Telugu Medium Courses under B. A, B. Com and B.Sc. programmes which were actually converted to English Medium as per the directions given by the Governemnt of A.P and so, the existing English Medium Sections Under B. A, B. Com and B.Sc. courses have to be closed down as there were no admissions for all the sections and there were no students admitted in the courses that were closed and received the withdrawal Oder from APSCHE.

Prof. G. Rosaih appreciated the Management, Staff and students for carrying out a number of activities during Lockdown. He suggested increasing the placements by inviting various companies to the Campus.



Prof. K. Ratna Shiela Mani, the State Government Nominee appreciated the Management, Staff and students for conducting many awareness programmes, Faculty Development programmers and Seminars and Workshops during COVID-19 pandemic. She suggested increasing research publications and applying for Research Projects.

The members appreciated for continuing to offer the Online Certificate Courses to the Students by every dept. In this regard, Rev. Fr. Dr. Francis Xavier SJ Suggested introducing the certificate course on coding and Programming by the Department of Computer Science as it offers the students high paying Jobs.
