Scribe Policy

In higher education institutions, a scribe policy typically pertains to accommodations provided to students with disabilities. Specifically, it involves allowing a student who has difficulty with writing due to a disability to have a scribe during exams or class activities.

The scribe's role is to write down the student's dictated responses verbatim without providing any assistance or interpretation of the content. This accommodation ensures that the student's knowledge and understanding are accurately assessed without being hindered by their impairment.

The policy usually outlines the procedures for requesting a scribe, the qualifications and responsibilities of the scribe, as well as any guidelines or limitations regarding the use of this accommodation. Additionally, it may address confidentiality concerns and provide guidance on how to ensure fairness and impartiality in the assessment process.

Guidelines

Guidelines for use of a scribe/paper writer for visually handicapped/ orthopedically handicapped candidates (whose writing speed is affected).

A scribe / paper writer to write the theory/ laboratory internal/ external examination on behalf of a visually handicapped (vh) candidate (blind) and orthopedically handicapped (OH) Candidate (whose writing speed is affected), maybe used. In all such cases where a scribe is used the follow rules will apply:

- The controller of examination will arrange scribe.
- The acdemic qualification of the scribe should not be more than intermediate/12th standard/puc.
- Both the candidate as well as the scribe will have to give suitable under taking as per
 format attached in annexure that the scribe fullfill all the stipulated eligibility criteria
 or had suppressed material facts, the examinations of the candidate will stand
 cancelled, irrespective of the result of the written examination.

Candidates who use a scribe will be eligible for extra time@ 30 minutes.
